USE AND BATHING REGULATIONS

(for the bathing area with sunbathing lawn at the campsite)

(Association of Austrian Baths)

1. Obligations of the owner

1.1. Granting of the use of the facilities, risk bearing

(4) The owner is responsible for the guests only

1.2. Opening times and granting of access

(1) The owner enables the bathing area to be visited with Sunbathing lawn at the campsite by the leisure and recreation facility in Kleblach during the following opening times:

Granting of access:

- May 1st to September 30th every year, daily in the Time from 8 a.m. to 10 p.m.
- October 1st to April 30th every year, every day during that time from 9 a.m. to 6 p.m.

Bathing operation:

- May 1st to September 30th every year, daily in the Time from 8 a.m. to 7 p.m.

(2) It is forbidden to use the facility outside of the opening times.

(3) If the officially admissible number of visitors is exceeded, the With the help of the responsible staff, the owner can grant access to others Prohibit visitors. In these cases, those willing to visit have Waiting times to be expected.

(4) The owner reserves the right to refuse persons whose admission to the Attendance seems questionable, to grant access without giving a reason refuse.

1.3. Condition and operation of the systems

(1) The owner is responsible for ensuring that the facilities are in accordance with the regulations erected, operated and maintained. In particular, the Owner of all applicable hygiene and safety regulations to be observed. The owner has no further obligations.
